VENDORS / EXHIBITORS CONTRACT

This is to certify that I, _____ as a legal representative of _____ (agency/business/group/individual name) agree to the following requirements for participation in the Hispanic Latino Festival annual fundraiser.

1. The exhibitor is responsible to provide any tents, tables, lights, generator for electricity, electrical cords and chairs as necessary.
2. Set-up and clean up of the space allotted to the exhibitor is the sole responsibility of said exhibitor. **And please do not leave any nails or screws used to hold the tent down in the ground; you will be responsible if any accident occur so use sand bags if necessary.**
3. All participants of Festival (including exhibitors, their employees, volunteers, and staff) must comply with all rules and regulations from the State of Florida, and the City of Sarasota.
4. **All exhibitors are required to bring two whole cases of garbage bags (at least 30 gals) and two garbage cans for general use at the Festival. It is the responsibility of the exhibitor to dispose of these (Garbage) cans at a DESIGNATED AREA OR GARBAGE TRUCK ON LOCATION. NOTE: (DO NOT THROW GARBAGE IN ANY GARBAGE CANS BELONGING TO THE RESTAURANTS) it is illegal and there will be additional charges for failure to comply with this requirement.**
5. Exhibitor (and its employees) shall indemnify, defend and hold harmless all Academy of Latin Arts and Science, Inc and Hispanic Latino Festival staff and representatives from claims, liabilities, costs and charges (including attorneys and paralegals fees and costs) for injury, loss or damage to property or persons (including death) arising out of Exhibitors activities in connection with the event, or any breach of representation, warranty or covenant in this contract or in the Terms and conditions of this agreement.

- **Food vendors:** \$500.00 application fees for a 10x10 space. (Application fees are non-refundable).
- **Others:** \$350.00 application fees for a 10x10 space. (Application fees are non-refundable).

A representative of the Academy of Latin Arts and Science will inspect the assigned site after the festival. It is understood that exhibitor will incur additional charges if any damage is made to City property or there is any trash left at the assigned space.

There will be a representative at the information booth the day of the festival between 5:00 PM and 9 PM to handle questions and issues.

I agree with all above requirements and hereby certify that these requirements shall be met.
